May 29-June 12, around Western North Carolina

Justice Forum

October 7, online

The annual Justice Forum brings together a diverse cross-section of the Western North Carolina community to learn about and discuss crucial issues affecting our region. Tickets are free and we expect an audience of 500-750. We select a nationally-renowned speaker to lead the discussion and motivate our community to create positive changes.

Java for Justice

September at coffee shops and restaurants around Western North Carolina

Participating coffee shops, bakeries, and restaurants help raise money and awareness for the need for civil legal aid to help low-income people avoid homelessness, access health care, and escape domestic violence.
